DECLARATION OF CONFORMITY

To whom it may concern;

Global Nonwoven does not have the complete laboratory capability required to test all of the mentioned legislation below, but can declare compatibilities by using documents provided by related raw material suppliers and can share these as needed. The following declarations for Global Nonwoven products are based on the best of our knowledge and declarations given by our suppliers but do not include testing of final products converted by our customers, which is fully under the customers responsibility.

Global Nonwoven products are defined as “**articles**” according to REACH definitions, therefore do not require registration under **REACH** regulation. We declare that the articles **Polypropylene (PP) Spunbond** (including colored and hydrophilic materials as well) and white **Meltblown** and **Medical SMS Nonwoven** and white **Spunlace** neither release substances nor contain dangerous chemicals included in the current **SVHC** lists and all these products complies with electrical equipment legislation (**RoHS**) as well. We confirm that our products do not contain, any chemicals listed under the **California Safe Drinking Water Toxic Enforcement Act of 1986** (Prop. 65, as amended), **TSE/BSE** (materials derived from animal origin) or **Genetically Modified Organisms (GMO)**, **Natural Rubber Latex (NRL)**, **Phthalate** compounds and **Conflict Minerals** (Dodd-Frank Act).

We declare that white Polypropylene Spunbond and Medical SMS Nonwoven and white Meltblown and white Spunlace type of products that we manufacture and substances contained in our supplied products are biocompatible according to our suppliers’ documentation and conform to our outsourcing product tests for cytotoxicity, sensitization and irritation (by standard series **ISO 10993-5**, **ISO 10993-10** and **ISO 10993-12**). Most of our suppliers have **OEKO-TEX Standard 100 Annex 6 (Class-I)** certification and Global Nonwoven has the same certifications for PP Spunbond and Medical SMS Nonwoven and white Meltblown and white Spunlace products (certificate number ; **21.HTR.70944**)

We would point out that our company has been certified and operates in accordance with formal management systems per **ISO 9001:2015**, **ISO 14001:2004**, **ISO 13485:2003**. This present declaration is based on the status of legislation at the date written below and is valid until the end of **2023**. It can be renewed upon request.
